

# Assetbase CPI +2% Prescient Fund of Funds

## Portfolio Objective and Strategy

The objective of the portfolio is to achieve a total performance of at least 2% per annum better than the inflation rate over rolling periods of 3 years or more. The portfolio manager will continually assess the prospects for asset classes and reflect this assessment in the portfolio.

The portfolio manager will research asset managers globally. The chosen asset managers' portfolios will be combined to achieve the total portfolio objective.

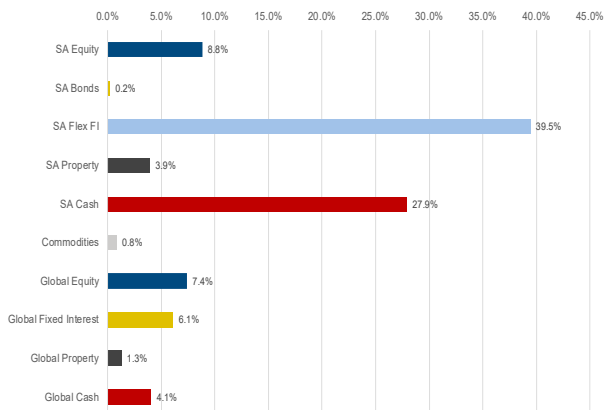
The portfolio will, at all times, comply with Regulation 28 of the Pension Funds Act.

## Manager Allocation

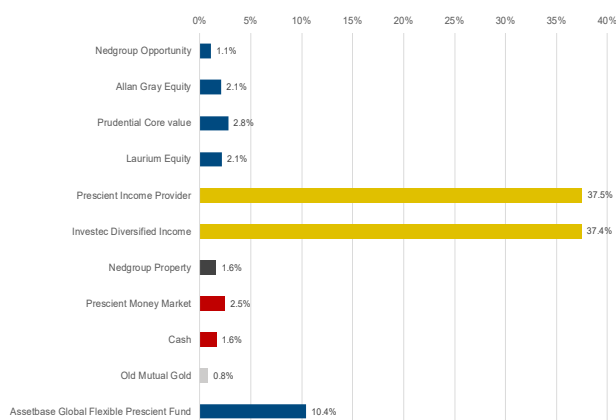
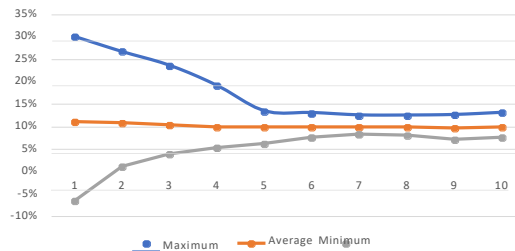

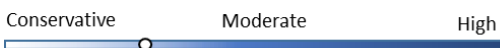

## Fund Manager Commentary

After a torrid calendar 2018, albeit finishing positively with a good December for South Africa, nearly all global markets started 2019 with a bang. The JSE was up nearly 3%, Germany and France nearly 6% and the US market over 7% for the month! The about-turn on the interest rate hike cycle announced by the US Fed seems to have buoyed investor sentiment as investors bought both stocks and bonds. Locally the miners did well but other rand-hedges such as British American Tobacco, and Sasol and Naspers disappointed. Granted Naspers was up for the month but only 0.5% compared to, say, miners and financials up considerably more. In the US, the FAANGs staged a bit of a comeback. Oil seems to be settling between \$60 and \$70 rather than \$10 lower but as long as there is some certainty about the range, investors can invest. The big story of the month was the strength in the Rand against all major currencies with the currency nudging close to R13/\$1 towards the end of the month. We took advantage of both strong interest rates and currency to take profits on the funds' bond positions which had yielded handsomely for the portfolios. The flexible income managers now offer a better yield without the duration risk.
