Fund Objective and Investment Process

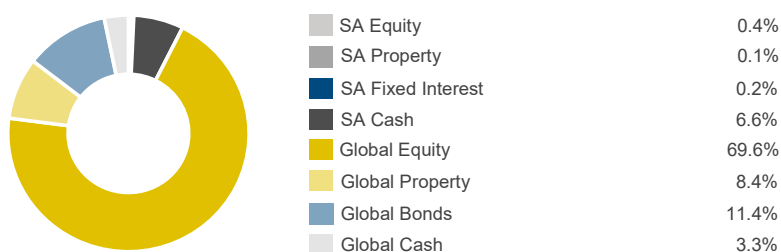
The objective of the portfolio is to achieve inflation-beating returns in US dollars over rolling periods of 5 years or more. The portfolio manager will continually assess the prospects for global asset classes and reflect this in the portfolio. The portfolio manager will research global asset managers across all sectors and combine portfolios to achieve the above objective. The portfolio will not comply with Regulation 28 of the Pension Funds Act. The portfolio is moderately aggressive and suits long-term investors looking for global growth and diversification into non-South African assets with high growth potential.

Global Assets

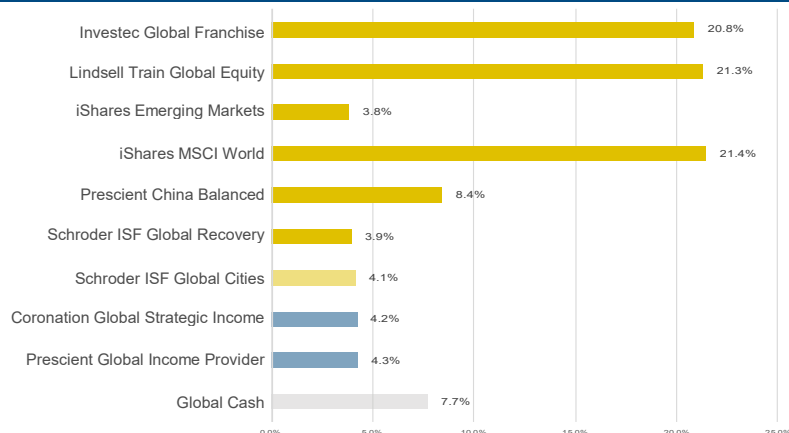

Fund Manager Commentary

The third quarter of 2020 was more benign than the first two quarters as markets drew breath and consolidated. Global volatility is still high as there are multiple places for uncertainty – the US Presidential election is days away, Brexit is unbelievably still unresolved after more than 4 years, China seems poised to launch more growth initiatives perhaps focused more domestically than globally and emerging markets remain fragile and dependent on what happens in the developed world. Despite supposed pundits forecasting the effect of a Biden win in the US, the effects on taxation, growth, inequality and, most importantly, relationships with China are unknown. Campaigning politicians always turn out differently to those in power so we have refrained from investing your money based on a single forecast or outcome. We have retained our philosophy of investing for growth in global companies, including South African Rand-hedges, and domestically for yield. As a result, we have used the last quarter to add to both global and domestic equity managers and have increased our exposure to Lindsell Train and 91 Global Franchise offshore and Fairtree, 91 and Truffle domestically. This has meant a consequent reduction in fixed interest managers and cash. The inflation targets for the South African portfolios remain challenging with the COVID ructions. The Global Flexible portfolio is performing well and is both ahead of its benchmark and in the upper quartile of competitive funds.

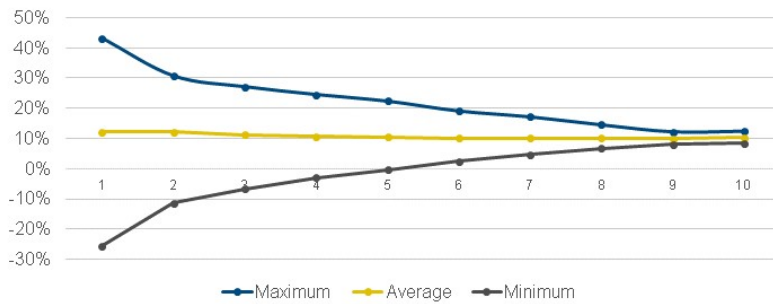
